

DAHLITZ MEDIA PUBLISHING AGREEMENT

1. The Author agrees to grant Dahlitz Media (“Publisher”), the irrevocable right to publish the Article in *The Neuropsychotherapist Magazine*, *Neurorobotics website*, *Age of Robots magazine*, and in subsequent special issues, reading courses, compilations, and/or associated websites. The Author irrevocably grants permission for the Article to remain on the associated website indefinitely. The Publisher will identify the Author (or the Author's agent who holds copyright) as the owner of the copyright in the Article.
2. All requests for commercial reprints will be referred to the Author (or the Author's agent). If the Article was first published in *The Neuropsychotherapist*, for example, subsequent reprints will contain the following: “This article first appeared in the [issue number] issue of *The Neuropsychotherapist*”, and similarly if published in our other publications.
3. The Author grants the Publisher the right to edit or abridge the Article at its discretion for publication, and/or inclusion in an online reading course, and to select a title and appropriate images to appear with the Article, without altering the meaning or intent of the Article. Editing will be a collaborative process between Publisher and Author to achieve accurate usage, spelling, punctuation, grammar, length and style for the publication.
4. The Author warrants and affirms that he/she/they is/are the original author and proprietor of the Article; that the Author has full power and authority to sign this Agreement; that the Article is not in the public domain; and that the Article does not infringe any statutory or common law copyright or any proprietary right of any third party.
5. The Author also warrants and affirms that the Article does not breach the confidentiality or privacy of any third person, or contain anything that would contravene the rights of a third person; and that the Article is in fact true, accurate, and based on reasonable research.
6. The Author agrees to hold the Publisher harmless from any suit, claim or demand for settlement that may be brought against the Publisher by reason of the publication of the Article.
7. Compensation and consideration for publishing rights will be 1 year subscription for *The Neuropsychotherapist* articles or 1 full page magazine advertisement for a feature article or 1/3 page advertisement for a column article for *Age of Robots* magazine.
